WHAT IS BEING PROPOSED?

The Alameda County Sheriff's Office (ACSO) announces a 30-day public comment period for the Draft Initial Study and proposed Negative Declaration pertaining to the Regional Training Center, Scenario Village Modernization Project. The Site is located within the existing boundaries of the ACSO Regional Training Center located at 6289 Madigan Road in the City of Dublin, CA. The Draft Initial Study addresses the following:

- ✓ Site investigation activities including the identification of potential significant effects and proposed remedial measures that will reduce or avoid those effects.
- ✓ A Phase I Hazardous Materials Survey with recommended testing and clean up measures.
- ✓ A Biological Survey with recommended measures to safeguard protected plant and animal species.

CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) – NEGATIVE DECLARATION

Based on an Initial Study, the ACSO has determined that no significant environmental impacts would result from the Scenario Village Modernization Project, therefore, in compliance with the CEQA, a Negative Declaration is proposed. The Negative Declaration, Initial Study, and all related documents are available for review and comment.
